The COOMET Presidential Council thanked Nikita Zvyagin for the report and discussed the possibility of involving more young metrologists from NMIs/DIs of COOMET member countries, adopting similar international initiatives, and implementing analogous ones at the regional level.

COOMET was represented at the meeting by COOMET President Lazizbek Saidoripov (online), COOMET Representative at the JCRB Nikita Zviagin (in person), COOMET Vice-President Evgeny Lazarenko (online), and the Head of COOMET Secretariat Marat Yunusov (in person).

The invitation from COOMET President Lazizbek Saidoripov to host the 49th JCRB Meeting in Tashkent (Uzbekistan) was noted.

Based on a study conducted, Azer Gurbanov presented the experiences of other RMOs in peer-reviewing QMS of NMIs/DIs, best practices that could be adopted by COOMET, and proposals for a revised format of the QMS confirmation of recognition.

The COOMET Presidential Council thanked Azer Gurbanov for the report.

(15) On proposals for financing COOMET projects, based on the EURAMET and GULFMET experience

COOMET Vice-President Mustafa Çetintaş reported on the proposals for funding COOMET projects, drawing on the experiences of EURAMET and GULFMET.

He noted that funding for EURAMET and GULFMET projects typically comes from the European Union and GSO funds, respectively. It was suggested to explore opportunities for financial support from interested cooperation partners for small-scale projects, such as the development of transfer standards for comparison purposes.

COOMET Vice-President Evgeny Lazarenko proposed considering this issue within joint programs with the EASC.

The COOMET Presidential Council thanked Mustafa Çetintaş for the report.

The COOMET President Lazizbek Saidoripov reported on the intentions to facilitate the signing of the CIPM MRA by authorized organizations of Armenia, Kyrgyzstan, and Tajikistan through consultations and clarifications on the challenges and opportunities of the Arrangement, including with the involvement of the BIPM.

It was mentioned that a seminar on this matter is planned for autumn 2025.

The Head of COOMET Secretariat Marat Yunusov noted the possibility for NMI/DIs of COOMET member countries to take the "CIPM Mutual Recognition Arrangement" course on the BIPM e-learning platform.

The COOMET Presidential Council thanked Lazizbek Saidoripov for the report.

The COOMET Presidential Council discussed all positions and suggested keeping the current distribution of tasks and responsibilities unchanged.

Considering the communication (2024]]], email) from the COOMET National Secretariat in China (Stella Zhu) regarding Xinhua Dai's transition to another position and the inability to continue duties as COOMET Vice-President, Marat Yunusov proposed that the Presidential Council present proposals on its composition.

After discussing the situation, the Presidential Council suggested postponing the decision until information is received from NIM (China) about the new COOMET Committee Member from China.

The COOMET Presidential Council thanked Marat Yunusov for the report.

The COOMET President Lazizbek Saidoripov proposed considering the transformation of cooperation concept draft aimed at strengthening interaction among NMIs/DIs of COOMET member countries by creating differentiated membership levels, introducing [symbolic] membership fees, and allowing participation of organizations with partner status.

The COOMET Presidential Council conceptually supported the approach of differentiating the rights and obligations of full and associate members and introducing annual fees. It was noted that the approach requires more detailed and comprehensive discussion. The COOMET TG-Doc was tasked with further development of this matter.

The COOMET Presidential Council thanked Lazizbek Saidoripov for the report.

To conceptually support the transformation of cooperation concept draft (Appendix 1), the approach of differentiating the rights and obligations of full and associate members, and the introduction of annual fees, while noting the need for more detailed and comprehensive discussion by the COOMET TG-Doc

The COOMET President Lazizbek Saidoripov suggested discussing the necessity of developing a Regulation for the COOMET Presidential Council, given the absence of such a document.

The COOMET Presidential Council noted the advantage of not having a separate COOMET document regulating the activities of the Presidential Council, as this provides flexibility in approaches to addressing cooperation issues, and decided that such development is not advisable.

The COOMET Presidential Council thanked Lazizbek Saidoripov for the report.

The COOMET Presidential Council considers it inadvisable to develop a separate COOMET document regulating the activities of the Presidential Council

(21) On holding the XI International competition "The Best Young Metrologist of COOMET-2025"

The Head of COOMET Secretariat Marat Yunusov reported that preparations for the XI International Competition "Best Young Metrologist of COOMET-2025" have not yet begun.

The COOMET President Lazizbek Saidoripov proposed holding the XI International Competition "Best Young Metrologist of COOMET-2025" in Tashkent (Uzbekistan) at UzNIM in autumn 2025. The COOMET Presidential Council supported this proposal.

The COOMET Presidential Council thanked Marat Yunusov for the report.

The COOMET Presidential Council noted that when determining the dates of meetings of both the COOMET Committee and other meetings of structural bodies, it is necessary to take into account the already planned meetings of international and regional metrology organizations in order to avoid possible problems with the participation of cooperation partners.

The COOMET Presidential Council noted that it is preferable to hold the 37th COOMET Committee meeting in May - April 2025.

The COOMET Presidential Council thanked Lazizbek Saidoripov for the report.

The transformation of cooperation concept DRAFT

Objective: Transformation of COOMET cooperation to strengthen interaction of member countries in the field of metrology through the creation of differentiated membership levels, introduction of symbolic membership fees and expansion of participation of organizations with partner status. These measures will support the activities of the COOMET Secretariat, improve the quality of events and attract additional stakeholders to exchange knowledge and best practices.

Conceptual apparatus

NMIs - National Metrology Institutes

DIs - Designated Institutes

CMCs - Calibration and Measurement Capabilities

CIPM MRA – Mutual recognition of national measurement standards and of calibration and measurement certificates issued by national metrology institutes

RMOs - Regional metrology organisations

COOMET MoU - COOMET D 1 "Memorandum of Understanding"

Partners – COOMET Members

Basic provisions of the concept

1. COOMET membership levels

In accordance with the new membership structure, a division into three categories is proposed:

Full members: NMIs / DIs⁴ or organisations performing the functions of NMIs / DIs that are a COOMET signatory MoU and publishing or seeking to publish their CMCs in the CIPM MRA (Appendix C) through COOMET.

Associate members: NMIs /DIs or organisations performing the functions of NMIs / DIs that are a COOMET signatory MoU and those publishing or seeking to publish their CMCs in the CIPM MRA (Appendix C) through other RMOs.

Partner organizations: other organizations, such as international metrology organizations, educational and research institutions, which are signatories to the COOMET Declaration of Partner Organizations.

2. Rights and responsibilities of each membership level

The table below presents the structure of financial obligations, rights and responsibilities for each membership category.

^{*} However, if one country/economy has several NMIs/DIs or organizations performing the functions of NMIs / DIs as full members, the partners representing that country/economy shall take the necessary measures to comply with the "One country – one vote" rule.

Membership fees are set at a symbolic level and are aimed at covering the travel and administrative costs of the COOMET Secretariat. These amounts should not be burdensome so as not to affect the participation of Partners in the work of COOMET.

3. Financial model

Symbolic contributions from full and associate members will partially cover the costs of business trips and participation of the COOMET Secretariat in international meetings and conferences. However, given the growing demands for global coordination, it is planned to attract additional sources of funding through partnership projects and grants.

4. Risks and measures to minimize them

The following risks may arise when introducing symbolic contributions:

Financial burden for Partners with limited resources: therefore, fees are set at a minimum level so as not to impede participation.

Potential reduction in interest in participation: expansion of educational programs and exchange of experience is envisaged, which will increase the attractiveness of membership for all categories.

Conclusion

The implementation of the concept of cooperation transformation will allow COOMET to strengthen ties between Partners, create a more flexible interaction structure and ensure sustainable development of the metrological network in the region.
